
Farewell

Board Allocates \$617,726 Back to Members

BKD CPAs & Advisors, LLP, of West Des Moines has completed the annual audit of Clarke Electric. Cheryl Clausen presented the audited 2021 statements to the board of directors at its April board meeting. The report showed all financial and operational documents to be fairly presented and in accordance with government auditing standards. The board reviews the statement of operations, equity, cash flows and deferred patronage schedule to determine how to allocate 2021 margins.

The margin is calculated by subtracting operating expenses from the total amount of money collected during the year, and is allocated to each member based on the amount each member paid for electricity. Service charges, membership fees and other payments are not included in the allocation.

This year, the board voted to allocate \$617,726 back to the members as 2021 patronage capital. They also voted to retire the patronage capital allocated for the remainder of 2004 and a portion of 2005 as dividends. Members of CEC during those years will see a credit on their account in December or as a check for former members.



May is Electrical Safety Month!

At Clarke Electric Cooperative, we recognize Electrical Safety Month every May, but we also know the importance of practicing safety year-round. From our co-op crews to you, we recognize that everyone plays a part in prioritizing safety.

To me, safety is more than a catchphrase. As general manager, it's my responsibility to keep co-op employees safe. We also want to keep you and your family safe. That's why we're available to educate about and demonstrate the dangers of living with electricity. We discuss emergency scenarios, such as what to do in a car accident involving a utility pole and downed power lines. We caution students on the dangers of pad-mounted transformers

and overloading circuits with too many electronic devices.

The Clarke Electric Cooperative Annual Meeting is coming up in September and the co-op is seeking candidates to run in three districts.

A nominating committee made up of two members from each district in the election will meet in June to select possible candidates.


If you are interested in serving on the board of Clarke Electric, call the cooperative for details. Any verified member of the eligible districts may add their name to the ballot by presenting a petition consisting of 15 signatures from residents within the district. The petition must be turned in to the cooperative 45 days before the Annual Meeting Sept. 12, or July 29, 2022.

Additionally, a special election will be held during the annual meeting to fill the vacant District 1 seat following the passing of Director Bill Willis. The board has appointed Natalie Rydl to fill the position until the election.

Our Board of Directors is elected by and from within the membership of Clarke Electric Cooperative. Being a director for Clarke Electric is a great opportunity to learn more about your cooperative, work with local legislators and give back to your community. A director must have the time to attend monthly board meetings, other special meetings and educational seminars designed to stay informed about the cooperative and utility industry. Reliability is our Business

Each year Clarke Electric reviews our system reliability and compares the results to previous years as well as to other cooperatives, investorowned and municipal utilities. The process helps us to identify ways we can decrease both the number and length of outages in our

longterm planning. In 2021, the extreme weather across our

short-

and

service territory in December led to lightning being the largest contributor of outages for the year, with wind being a very close second. According to the National Oceanic and Atmospheric Association (NOAA), 43 tornadoes were recorded in Iowa on Dec. 15,

making it the most substantial tornado outbreak in state history.

We use this data to create a reliability plan that is filed with the Iowa Utilities Board (IUB). This plan acts as our guide when we evaluate equipment choices, right

> of way clearing, pole inspection, animal protection guards, lightning protection equipment and other items. Our end-of-year

Reliability Report is submitted to the board of directors and the IUB annually for review. This is another way we ensure our members have the power for their homes and businesses when they need it. We work for you!



Planning to Build or Upgrade Electric Service?

If you are planning to build or upgrade your electric service this season, please call Clarke Electric first. Below is a list of questions for you to consider before contacting us.

Where is the new property located?

- Address
- · Township, Range and section number.

Is the new home/building staked out on the property?

· Is the driveway also staked or laid out?

What type of heating and appliances will be utilized?

- · If electric, what KW size is the heating unit?
- Gas
- · Wood (heat)

Are there any other outbuildings being constructed, or will there be in the future?

You may need an upgrade to your electric service if you are:

- · building a new home to replace your existing home;
- · adding an addition to your current home;
- · building a new outbuilding/shop;
- adding a grain bin or large motor load to your existing service;
- updating your panel size in your home;
- upgrading or replacing your HV/AC system; or
- adding an electric vehicle charger.

It is important to us to know any additional electric load you plan to add to your existing service. If you are not sure of the size of your service don't hesitate to call in and request that information. This will ensure Clarke Electric continues to provide you with proper and reliable electrical service.

Consult both your electrical contractor and Clarke Electric Cooperative as you plan your project so that we can work together to meet your expectations.

Note: Clarke Electric is experiencing material shortages, extensive lead times and a large demand for material stock. We are doing our best to plan ahead to keep up with our members' power requirements.

District 5: Ed White, board president (completing his second term)

District 1: Natalie Rydl, director

The following are excerpts from the Cooperative Bylaws and Articles of Incorporation regarding director elections:

Article III, Section 2, **Qualifications and Tenure.** From and after the annual meeting in 2014, "No member shall be eligible to become or remain a director or to hold any position of trust in the Cooperative, whose primary residence is not served by the Cooperative, or who is in any way employed by or who is married to an employee of the Cooperative or who has been an employee or married to an employee of the Cooperative within the past three years or who is financially interested in a competing enterprise or a business selling electric energy or supplies to the Cooperative."

Article III, Section 3,
Nomination and Election of
Directors. It shall be the duty
of the board to appoint, not less
than 60 days and not more than
90 days before the date for the
meeting of members at which
directors are to be elected, a
committee on nominations ...
Said committee shall consist of
two members from each of the
districts where the terms are
to expire following the annual

meeting ... The committee shall prepare and post at the principal office of the cooperative, at least 45 days before the meeting a list of the nominees for directors. The committee shall be encouraged, but shall not be required, to nominate not less than two candidates for each district for which a director is to be elected.

Any fifteen or more members acting together may make other nominations by petition not less than 45 days prior to the meeting and the secretary shall post such nominations at the same place where the list of nominations made by the committee is posted, providing that said nominations made by petition shall be limited to members from the district for which a director is to be elected and the petitioners must also be from said district.

(b) Election of Directors "Election of directors shall be by printed ballot. The ballot shall list the candidates nominated by the committee on nominations and by petition, if any, arranged by the districts. The secretary shall mail a ballot marked. "Ballot for Election of Directors" and a statement of the number of directors to be elected and showing separately the nominations made by the committee andby petition. The statement shall also contain and inform the members of the manner in which they may vote by mail for directors as provided in this section."
